IMPORTANT INSTRUCTION TO CANDIDATES

Application for the statement of eligibility should be accompanied with the necessary certificates in Original and typed copy of each and the prescribed fee or Rs 250/- or Rs 500/- as the case may be for the statement of eligibility.

A statement of eligibility will be issued of the students at her own risk if she found prima facie eligible for admission and on condition that she submits to the **Pariksha Bhavan, S.N.D.T. Women's University, Santacruz, Mumbai 400 049.** through the Head /Principal of Institution / college joined by her in University the necessary certificate in original together with a typed copy of each for confirmation of her eligibility before the close of the academic term in which she is provisionally admitted in this University.

The statement of eligibility issued for the purpose of seeking admission to the University in a particular year will not be valid for the purposed of seeking admission in the following year.

Admission to the University Departments and / or constituent college of this University are made by the Head of the respective Department and / or the Principal of the constituent college concerned. The University does not undertake to arrange admissions or accept responsibility for the admission either to the University Department or Constituent colleges.

The statement of eligibility dose not assure the holder of a seal in this University. It only declares students eligibility for admission to the course of the study in this University.

The students seeking admission to this University has to approach the Principal of the College which she wishes to join the matter of her admission and for other relevant information relating to tuition fees, hostel, accommodation, courses of study etc.

The University does not recognise foreign examination on a regular basis but application of person desirous of seeking admission to this University on the basis of qualifications obtained in foreign countries are consider or admission to this University on merits of each individual case. For this purposed passing certificates, transcripts of records and copy of syllabus containing the details of the studies pursued in the various subject at the examination passed by the applicant's (duly countersigned by the Higher Commissioner of India in the country or the country or Officer authorized by him) and standard of passing laid down at the examination should be forwarded to this office well in advance. In case the certificate or transcripts are in a language other than English, an English translation of the same, duly certified by a competent authority should be sent.

The University does not have any bursaries or scholarships which can be offered to foreign students.

It is important for student coming for another country to note that she should not come unless she had a definite offer of admission and is also assured of all other facilities such as hostel accommodation ets.which she may need along with proper students visa.

A student from another University or Board of Secondary or intermediate Education or any other statutory Examining Body seeking admission to this University is required to apply to the **Registrar** for statement of eligibility in the form prescribed by the University.

A student from another University or Board of Secondary or intermediate Education or Examining body seeking admission to the University shall be admitted to a college affiliated to this University after expiry of one month from the date of commencement of any term. Provided, however that if the Principal of a college is satisfied that there was sufficient reason for delay on the part of a student seeking admission as aforesaid, he / she may admit the student to the college notwithstanding the expiry of one month. If the principal has reason to believe that the student would be able to keep the necessary attendance prescribed by the University for the class to which she seeks admission.
