8. If any candidate directly or indirectly tries to influence any officer of the University, he / she will be disqualified.
- 9. Executive Assistant to Vice – Chancellor, Stenographer Grade C/ Computer Operator & Peon (Administrative posts) shall be selected as per the procedure laid down under the Rules of the University/State Government of Maharashtra.**
