Accordingly, a few corrections as reported by the teachers concerned have been duly carried out after verification, as per the provision of Section 8(4) of the aforestated Uniform Statute No.1 of 2017.

The Corrected Electoral Roll of the Teachers for the aforestated purpose has now been accordingly prepared as per Section 8(4) of the Uniform Statute No.1 of 2017 and published by the University on the "Election Portal" on its website www.sndt.ac.in. In case of any dispute, an appeal against the said Corrected Electoral Roll shall be preferred to the Vice-Chancellor within five days from the date of its publication i.e. on or before August 30, 2017 and the Vice-Chancellor's decision shall be final.
