

**CORRECTED ELECTORAL ROLL  
OF THE PRINCIPALS FOR ELECTION TO THE SENATE**

Whereas, as per the Circular no. Univ.Sec./Elec.Sen./Princi./Prov.Elec.Roll/2017-18/92 dt. July 11, 2017, the Provisional Electoral Roll of the Principals, as defined under Section 2(44) of the Maharashtra Public Universities Act, 2016 and as prepared for the purpose of election of ten Principals to the Senate, under Section 28(2)(o) of the said Act was published for the information of concerned Principal on July 11, 2017. The Provisional Electoral Roll of the Principals was published on the "Election Portal" of the University on its official website [www.sndt.ac.in](http://www.sndt.ac.in), as per Section 8(3) of the Maharashtra Public Universities (Procedure for Conduct of Election to various Authorities and Bodies of the University) Uniform Statute, 2017 (Uniform Statute No.1 of 2017).

The concerned Principals were further requested to peruse the aforesaid Provisional Electoral Roll of the Principals so published on the "Election Portal" of the University and in case, any omissions or wrong entries were found in the said Provisional Electoral Roll, the same were to be brought to the notice of this office in writing within five days of its publication on or before July 17, 2017 upto 5.00 p.m. alongwith the copies of the relevant documents, for carrying out the necessary corrections. Accordingly, a few corrections as reported by the concerned Principals have been duly carried out after verification, as per the provision of Section 8 (4) of the aforesaid Uniform Statute No.1 of 2017.

The Corrected Electoral Roll of the Principals has now been accordingly prepared as per Section 8(4) of the Uniform Statute No.1 of 2017 and published by the University on the "Election Portal" on its website [www.sndt.ac.in](http://www.sndt.ac.in). In case of any dispute, an appeal against the said Corrected Electoral Roll shall be preferred to the Vice-Chancellor within five days from the date of its publication and the Vice-Chancellor's decision shall be final.
