The Corrected Electoral Roll of the Teachers has now been accordingly prepared as per Section 8(4) of the Uniform Statute No.1 of 2017 and published by the University on the "Election Portal" on its website <a href="www.sndt.ac.in">www.sndt.ac.in</a>. In case of any dispute, an appeal against the said Corrected Electoral Roll shall be preferred to the Vice-Chancellor within five days from the date of its publication and the Vice-Chancellor's decision shall be final.
