**CORRECTED ELECTORAL ROLL OF THE REGISTERED GRADUATES FOR THE
ELECTION OF TEN REGISTERED GRADUATES TO THE SENATE**

Whereas, as per the Circular no. Univ.Sec./Elec.Sen./Reg.Gra./Prov.Elec.Roll/2017-18/101 dt. July 13, 2017, the Provisional Electoral Roll of the Registered Graduates of the Shreemati Nathibai Damodar Thackersey Women's University, Mumbai as defined under Section 2(47) of the Maharashtra Public Universities Act, 2016 and as prepared for the time being, in accordance with the provision of Section 131(5) of the Maharashtra Public Universities Act, 2016 for the purpose of election of ten Registered Graduates to the Senate, under Section 28(2)(t) of the said Act was published for the information of the concerned Registered Graduates on July 13, 2017. The said Provisional Electoral Roll of the Registered Graduates was published on the "Election Portal" of the University on its official website www.sndt.ac.in, as per Section 8(3) of the Maharashtra Public Universities (Procedure for Conduct of Election to various Authorities and Bodies of the University) Uniform Statute No.1 of 2017.

Whereas, as per the circular no. SNDT/Reg.Gra./2017-18/117 dt. July 26, 2017, the graduates who had not submitted the copies of Degree Certificate and proof of residence alongwith their applications in prescribed proforma for registration in the Register of Registered Graduates and for enrolment of the Registered Graduates were requested to submit the same on or before August 05, 2017.

Whereas, as per the provision of Section 3(2) of the Maharashtra Public Universities (Form of Registration of Graduates and Payment of Fees) Uniform Statute 2017 (Uniform Statute No.2 of 2017), all persons whose names are entered in the Register of Registered Graduates shall be entitled to register their names in the Electoral Roll of Registered Graduates. Accordingly, the University vide its notification dt. June 3, 2017 as published at the national level newspapers and also on its "Election Portal" on its official website has notified that, the Registered Graduates who intend to register their names in the Electoral Roll of Registered Graduates should fill up the Form 'B', as available on the said Election Portal and to submit the same alongwith the copies of relevant documents on or before July 05, 2017.

Accordingly, the duly filled in Form 'B' as submitted by the Registered Graduates alongwith the copies of the relevant documents have been scrutinized by a committee appointed for the purpose of preparation of Corrected Electoral Roll of Registered Graduates. The names of only those Registered Graduates who applied for registration on Electoral Roll of Registered Graduates, and whose application for registration were found valid have now been included the Corrected Electoral Roll of the Registered Graduates.

The Corrected Electoral Roll of the Registered Graduates of the University has now been accordingly prepared and published by the University on the "Election Portal" on its website www.sndt.ac.in, as required under Section 8(4) of the Maharashtra Public Universities Act, 2016. In case of any dispute, an appeal against the said Corrected Electoral Roll shall be preferred to the Vice-Chancellor within five days from the date of its publication and the Vice-Chancellor's decision shall be final.
