All the concerned are hereby informed that, the Provisional Electoral Rolls of Heads of Departments, in the following subjects or group of subjects from affiliated colleges and recognized institutions prepared as per the provision of Section 8(3) of the Maharashtra Public Universities (Procedure for Conduct of Elections to various Authorities and Bodies of the University) Uniform Statute, 2017 (Uniform Statute No. 1 of 2017) were published on August 23, 2017 for the purpose of elections of three Heads of Departments in the concerned subjects from affiliated colleges and recognized institutions to the respective Boards of Studies, under Section 40(2)(c) of the Maharashtra Public Universities Act, 2016 for a term of five years from September 01, 2017 to August 31, 2022.



The said Provisional Electoral Rolls of Heads of Departments in aforesaid subjects from affiliated colleges and recognized institutions was published on the "Election Portal" of the University on its official website www.sndt.ac.in, as per Section 8(3) of the Maharashtra Public Universities (Procedure for Conduct of Election to various Authorities and Bodies of the University) Uniform Statute, 2017.

Further, the concerned Heads of Departments in various subjects, from affiliated colleges and recognized institutions were requested to peruse the aforesaid Electoral Rolls of the Heads of Departments so published on the "Election Portal" of the University and in case, any omissions or wrong entries were found in the said Provisional Electoral Rolls, the same were to be intimated in writing to this office on or before August 30, 2017 upto 5.00 p.m. alongwith relevant documents, for carrying out the necessary corrections. Accordingly, a few omissions / wrong entries as reported by the concerned Heads of Departments have been duly carried out after verification as per the provision of Section 8(4) of the Uniform Statute No. 1 of 2017.

The Corrected Electoral Rolls of the Heads of Departments for the aforesaid purpose has now been accordingly prepared as per Section 8(4) of the Uniform Statute No.1 of 2017 and published by the University on the "Election Portal" on its website www.sndt.ac.in. In case of any dispute, an appeal against the said Corrected Electoral Rolls shall be preferred to the Vice-Chancellor within five days from the date of its publication i.e. on or before September 13, 2017 and the Vice-Chancellor's decision shall be final.
