

**FINAL ELECTORAL ROLL OF THE REPRESENTATIVES OF THE
MANAGEMENTS OF AFFILIATED COLLEGES OR UNSTITUTIONS
FOR ELECTION TO THE SENATE**

Whereas, as per the circular no. Univ.Sec./Elec.Sen./Mgt.Rep./Corr.Elec.Roll/2017-18/ 109 dated July 19, 2017, the Corrected Electoral Roll of the Representatives of the Managements of affiliated colleges or institutions as prepared for the purpose of election of six Representatives of Managements of affiliated colleges or institutions to the Senate, under Section 28(2)(p) of the Maharashtra Public Universities Act, 2016 and Section 8(4) of the Maharashtra Public Universities (Procedure for Conduct of Election to various Authorities and the Bodies of the University) Uniform Statute, 2017 (Uniform Statute No.1 of 2017) was published on July 19, 2017 on the "Election Portal" on the University Website www.sndt.ac.in for the information of the Representatives of the Managements. It was further informed that, in case of any dispute, an appeal against the said Corrected Electoral Roll should be preferred to the Vice-Chancellor within five days from the date of its publication and the Vice-Chancellor's decision to be final. However, no dispute whatsoever with regard to the aforesaid Corrected Electoral Roll was preferred within the stipulated time limit. There were no corrections to be made in the said Corrected Electoral Roll.

The Final Electoral Roll of the Representatives of the Managements has now been accordingly prepared, as per Section 8(5) of the Uniform Statute No.1 of 2017 and published on the designated notice board and also on "Election Portal" on the University Website www.sndt.ac.in, as required under Section 8(6) of the Uniform Statute No.1 of 2017, so that, the same can be downloaded free of costs.

The printed copies of the Final Electoral Roll shall be delivered on application to any person on payment of fee of Rs.5/- (Rupees five only) by cash. The postal charges will be payable extra.
