

**FINAL ELECTORAL ROLL OF THE REGISTERED GRADUATES FOR THE
ELECTION OF TEN REGISTERED GRADUATES TO THE SENATE**

Whereas, as per the Circular no. Univ.Sec./Elec.Sen./Reg.Gra./C.E.R.Elec.Roll/2017-18/175 dt. September 21, 2017, the Corrected Electoral Roll of the Registered Graduates of the Shreemati Nathibai Damodar Thackersey Women's University, Mumbai as defined under Section 2(61) of the Maharashtra Public Universities Act, 2016 (hereinafter referred to as "Act") as prepared for the purpose of election of ten Registered Graduates to the Senate, under Section 28(2)(t) of the Act and Sections 8(1) and 8(4) of the Maharashtra Public Universities (Procedure for Conduct of Election to various Authorities and the Bodies of the University) Uniform Statute, 2017 (Uniform Statute No. 1 of 2017) was published on the "Election Portal" on the University Website www.sndt.ac.in for the information of the concerned Registered Graduates. It was further informed that, in case of any dispute on appeal against the said Corrected Electoral Roll should be preferred to the Vice-Chancellor within five days from the date of its publication and the Vice-Chancellor's decision to be final. However, no dispute whatsoever with regard to the aforesaid Corrected electoral Roll was preferred within the stipulated time limit. There were no corrections to be made in the said Corrected Electoral Roll.

Accordingly, the Final Electoral Roll for the Collegium of Registered Graduates as defined under Section 2(47) of the Act is prepared and published on the "Election Portal" on the University Website www.sndt.ac.in and also on the designated notice board, as required under Section 8(6) of the Uniform Statute No. 1 of 2017, so that the same can be downloaded free of cost.

The printed copies of the Final Electoral Roll for the Registered Graduates so prepared and published for the election of ten Registered Graduates to the Senate, under Section 28(2)(t) of the Act shall be delivered on application to any person on payment of fee of Rs. 5/- (Rupees Five Only) by cash or by demand draft drawn in favour of "The Registrar, S.N.D.T. Women's University", payable at Mumbai. The postal charges shall be payable extra.
