( u/s 28(2)(r) OF M.P.U ACT, 2016**

It is hereby notified for the information of the concerned voters that, as per the circular no. Uni.Sec./Elec.Sen./Ten Teachers/Scrutiny/2017-18/182 dt. September 27, 2017, the list of valid and invalid nominations for the election of ten teachers, other than Principals and Directors of recognised institutions to the Senate, under Section 28(2)(r) of the Maharashtra Public Universities Act, 2016 was published by the University on the Election Portal on its official website. The last date for withdrawal of valid nominations as stated in the Schedule of the aforesaid Election was October 3, 2017.


