It is hereby notified for the information of the concerned voters that, as per the circular no. Uni.Sec./Elec.Sen./Uni. Teachers/Scrutiny/2017-18/184 dt. September 27, 2017, the list of valid and invalid nominations for the election of three University Teachers, to the Senate, under Section 28(2)(s) of the Maharashtra Public Universities Act, 2016 was published by the University on the Election Portal on its official website. The last date for withdrawal of valid nominations as stated in the Schedule of the aforesaid Election was October 3, 2017.

Whereas, as per the provision of Section 12(4) of the Uniform Statute No.1 of 2017, the names of the contesting candidates are required to be notified to the voters within three days after the last date of withdrawal of nominations.


