
**NOTIFYING THE NAMES OF CANDIDATES WHO ARE CONTESTING
THE ENSUING ELECTION OF TWO TEACHERS REPRESENTING
EACH FACULTY TO THE ACADEMIC COUNCIL
UNDER SECTION 32(3)(g) OF M.P.U.Act, 2016)**

It is hereby notified for the information of the all concerned that, as per the circular no. Univ.Sec./Elec.A.C./2T.Fac/Scrutiny/2017-18/208 dt. October 07, 2017, the status of validity of nominations so received for the election of two Teachers representing following four Faculties, with not less than fifteen years teaching experience to the Academic Council by the Collegiums of Teachers from amongst themselves (out of whom one each shall be a person belonging to Scheduled Castes or Scheduled Tribes or De-notified Tribes (Vimukta Jatis) / Nomadic Tribes or Other Backward Classes, provided that, the reservation per Faculty shall be decided by drawing lots), under Section 32(3)(g) of the Maharashtra Public Universities Act, 2016 was published by the University on the Election Portal on its official website www.sndt.ac.in on October 07, 2017.

1. Faculty of Science & Technology,
2. Faculty of Commerce and Management,
3. Faculty of Humanities,
4. Faculty of Inter-Disciplinary Studies.

The last date for submission of appeal about the validity of nominations to the Vice-Chancellor and the dates of declaration of decision of the Vice-Chancellor on the appeal were 09.10.2017 and 10.10.2017 respectively. Accordingly, one appeal on the validity of a nomination for election of two Teachers representing the Faculty of Inter Disciplinary Studies was received. However, the same was rejected by the Vice-Chancellor and the decision of the Scrutiny Committee to declare the nomination in question as INVALID was upheld by the Vice-Chancellor.

Since, there are no valid nominations, there will be no election of two Teachers representing each Faculty to the Academic Council, under Section 32(3)(g) of the Maharashtra Public Universities Act, 2016.
