DECLARATION OF RESULT OF ELECTION OF SIX REPRESENTATIVES OF MANAGEMENT OF AFFILIATED COLLEGES OR INSTITUTIONS TO THE SENATE FROM AMONG THE COLLEGIUM OF MANAGEMENT REPRESENTATIVES, UNDER SECTION 28(2)(p) OF THE M.P.U ACT, 2016

All the concerned are hereby informed that, as per the Schedule of Election approved by the Vice-Chancellor, the election of six Representatives of Management of affiliated colleges or institutions to the Senate from among the Collegium of Management Representatives of the affiliated colleges or institutions, out of whom one shall be a person belonging to Scheduled Castes or Scheduled Tribes or De-notified Tribes (Vimukta Jatis) / Nomadic Tribes or Other Backward Classes by rotation and one shall be a women, was scheduled to be held on October 11, 2017, under Section 28(2)(p) of the Maharashtra Public Universities Act, 2016 and in accordance with the eligibility conditions for being elected as a member of the Senate, as specified by the Government of Maharashtra, in its Notification No. MNS-2016/(347/(16)/e-3 dt. 28th April, 2017 in Sr.No.1(ii) of Schedule I and as per the procedure as prescribed by the Maharashtra Public Universities (Procedure for Conduct of Elections to various Authorities and Bodies of the University) Uniform Statute 2017 (Uniform Statute No.1 of 2017)

Whereas, as per the University Notification No.SNDT/Elec.Senate/6 M.R. /Contesting Candi/2017-18/195 dt. October 4, 2017, the names of contesting candidates whose nominations were found valid for the aforestated election of six Representatives of Management were notified for the information of voters, as per Section 1 of Uniform Statute No.1 of 2017. It was further notified that, if the number of valid nominations for the said election did not exceed the number of vacancies to be filled from the respective categories (Open-04, SC-01, and Women-01), the candidates nominated would be declared to have been elected on the date of declaration of result of election i.e. October 12, 2017, as per the provision of Section 10(8) of the Uniform Statute No.1 of 2017.

Whereas, the number of valid nominations received under Open Category were only three and for the Women Category only one and there was no valid nomination for Scheduled Caste Category for the election in question, as notified by the University vide Notification No. SNDT / Elec.Senate /10 Princi/Contesting Candi/2017-18/194 dt. October 04, 2017. Since the number of valid nominations for five seats for Open Category and one seat for Women Category did not exceed the number of vacancies to be filled under Section 28(2) (o) of the Act, the candidates have been declared ELECTED UNCONTESTED to the Senate against the vacancies in the respective category, as per the provision of Section 10(8) of the Uniform Statute No.1 of 2017.
