**DECLARATION OF RESULT OF ELECTION OF TEN PRINCIPALS OF
AFFILIATED, CONDUCTED, AUTONOMOUS COLLEGES TO THE SENATE BY
THE COLLEGIUM OF PRINCIPALS FROM AMONGST THEMSELVES, UNDER
SECTION 28(2)(o) OF THE M.P.U ACT, 2016**

All the concerned are hereby informed that, as per the Schedule of Election approved by the Vice-Chancellor, the election of ten Principals of affiliated, conducted, autonomous colleges which are accredited by National Assessment and Accreditation Council (NAAC) or National Board of Accreditation (NBA), as the case may be, to the Senate by the Collegium of Principals from amongst themselves, of whom one shall be a person belonging to Scheduled Castes, Scheduled Tribes, De-notified Tribes (Vimukta Jatis) or Nomadic Tribes, Other Backward Classes and one shall be a women was scheduled on October 11, 2017 was scheduled to be held on October 11, 2017, under Section 28(2)(o) of the Maharashtra Public Universities Act, 2016 and in accordance with the eligibility conditions for being elected as a member of the Senate, as specified by the Government of Maharashtra, in its Notification No. MNS-2016/(347/(16)/e-3 dt. 28th April, 2017 in Sr.No.1(iii) of Schedule I and as per the procedure as prescribed by the Maharashtra Public Universities (Procedure for Conduct of Elections to various Authorities and Bodies of the University) Uniform Statute 2017 (Uniform Statute No.1 of 2017)

Whereas, as per the University Notification No.SNDT/Elec.Senate/10 Princi/Contesting Candi/2017-18/194 dt. October 4, 2017, the names of contesting candidates whose nominations were found valid for the aforesated election of ten Principals were notified for the information of voters, as per Section 1 of Uniform Statute No.1 of 2017. It was further notified that, if the number of valid nominations for the said election did not exceed the number of vacancies to be filled from the respective categories (Open-05, SC-01, ST-01, NT/DT-01 OBC-1 and Women-01), the candidates nominated would be declared to have been elected on the date of declaration of result of election i.e. October 12, 2017, as per the provision of Section 10(8) of the Uniform Statute No.1 of 2017.

Whereas, the number of valid nominations under all the six categories for the election in question, as notified by the University vide notification No. SNTD / Elec.Senate /10 Princi/Contesting Candi/2017-18/194 dt. October 04, 2017 did not exceed the number of vacancies to be filled under Section 28(2) (o) of the Act, the candidates have been declared ELECTED UNCONTESTED to the Senate against the vacancies in the respective category, as per the provision of Section 10(8) of the Uniform Statute No.1 of 2017.


