# DECLARATION OF RESULT OF ELECTION OF TEN REGISTERED GRADUATES UNDER SECTION 28(2)(t) OF THE M.P.U ACT, 2016

All the concerned are hereby informed that, as per the Schedule of Election approved by the Vice-Chancellor, the election of ten Registered Graduates having graduated five years prior to the date of nomination from amongst the Collegium of Registered Graduates under Section 28(2)(t) of the Maharashtra Public Universities Act, 2016, to the Senate was scheduled on November 06, 2017, under Section 28(2)(t) of the Maharashtra Public Universities Act, 2016 and in accordance with the eligibility conditions for being elected as a member of the Senate, as specified by the Government of Maharashtra, in its Notification No. MNS-2016/(347/(16)/e-3 dt. 28<sup>th</sup> April, 2017 in Sr.No.1(v) of Schedule I and as per the procedure as prescribed by the Maharashtra Public Universities (Procedure for Conduct of Elections to various Authorities and Bodies of the University) Uniform Statute 2017 (Uniform Statute No.1 of 2017)

Whereas, as per the University Notification No. SNDT / Elec.Senate /10 R.G./Contesting Candi/2017-18/234 dt. October 27, 2017, the names of contesting candidates whose nominations were found valid for the aforestated election of ten Registered Graduates were notified for the information of voters, as per Section 1 of Uniform Statute No.1 of 2017. It was further notified that, if the number of valid nominations for the said election did not exceed the number of vacancies to be filled from the respective categories (Open-05, SC-01, ST-01, NT/DT-01 OBC-1 and Women-01), the candidates nominated would be declared to have been elected on the date of declaration of result of election i.e. November 06, 2017, as per the provision of Section 10(8) of the Uniform Statute No.1 of 2017.

Whereas, the number of valid nominations under all the six categories for the election in question, as notified by the University vide notification No. SNDT / Elec.Senate /10 R.G./Contesting Candi/2017-18/234 dt. October 27, 2017 did not exceed the number of vacancies to be filled under Section 28(2)(t) of the Act, the candidates have been therefore declared ELECTED UNCONTESTED to the Senate against the vacancies in the respective category, as per the provision of Section 10(8) of the Uniform Statute No.1 of 2017, mentioned herein below:

## Term of office of members of the Senate

As per the provision of Section 62 of the Maharashtra Public Universities Act, 2016, the term of the members who have been declared elected to the Senate shall be five years commencing from September 01, 2017 and expire on August 31, 2022, irrespective of the date on which the aforesaid members have entered upon his /her office, subject to the provision of Section 63 of the Act.

### Election of a candidate from more than one constituency

As per Section 18 of the Uniform Statute No.1 of 2017, if any candidate is elected, nominated or co-opted to any authority or body in more than one capacity, he shall by notice in writing signed by him and delivered to the Registrar of the University within seven days of the declaration of the result of the last date of such election, nomination or co-option, as the case may, choose which of the capacities he shall hold, and such choice shall be conclusive.

If the candidate does not make the choice referred to herein within the specified period of time, the Vice-Chancellor shall decide the capacity which he would hold and his decision shall be final.

When any such choice has been made by the candidate or a decision given by the Vice-Chancellor, the Vice-Chancellor shall direct the Registrar to take steps for holding an election or carrying out the process of nomination or co-option, as the case may be, in which office of a member such vacancy has occurred by reason of such choice.
