## NOTIFICATION

PREPARATION OF ELECTORAL ROLL OF TEACHERS FOR ELECTION OF TWO TEACHERS REPRESENTING EACH FACULTY TO THE ACADEMIC COUNCIL UNDER SECTION 32(3)(g) OF THE MAHARASHTRA PUBLIC UNIVERSITIES ACT, 2016.

It is hereby notified for the information of all the concerned that, as per the provision of Section 32(2)(g) of the Maharashtra Public Universities Act, 2016, two teachers representing each Faculty with not less than fifteen years teaching experience are to be elected to the Academic Council by the collegium of teachers from amongst themselves, out of whom one each shall be a person belonging to Scheduled Castes or Scheduled Tribes or Denotified Tribes (Vimukta Jatis) / Nomadic Tribes or Other Backward Classes provided that, the reservation per Faculty shall be decided by drawing lots and provided further that out of the teachers representing each Faculty, one shall be a woman to be decided by lots, for a term of five years from September 01,2017 to August 30, 2022.

Whereas, as per the eligibility conditions for being elected as a member of the Academic Council under Section 32(3)(g) of the Maharashtra Public Universities Act, 2016, as specified by the Govt. of Maharashtra, vide notification dated 8<sup>th</sup> April 2017, are as under:

## Two Teachers representing each Faulty to be elected to the Academic Council.

a) Shall posses Ph.D. Degree,

b) Shall have at least 15 years aggregate teaching experience,

c) Shall be a recognised Ph.D. Guide under whose supervision, at least two students have been awarded Ph.D. Degree,

d) Shall have authored / co-authorised at least two text books / reference books or shall have published at least three research papers in peer reviewed journals at first / corresponding author.

e) Shall have undertaken university examination related work for at least five years in aggregate.

Whereas, as per Section 2(61) of the Maharashtra Public Universities Act, 2016, "teacher" means full time approved Professor, Associate Professor, Assistant Professor, Reader, Lecturer, Librarian, Principal, Director of an institution, Director of Knowledge Resource Centre, Director of Centre of Lifelong Learning and Extension, Deputy or Assistant Librarian in the University, College Librarian, Director or Instructor of Physical Education in any University Department, conducted, affiliated or autonomous college, autonomous institution or department or recognized institution of the university.

Whereas, the Vice-Chancellor vide order no. Univ.Sec/Fac-BOS/VC Dir/2017-18/ dated 18<sup>th</sup> June, 2018 issued the "Direction for Governing Constitution of Faculties and Boards of Studies in S.N.D.T. Women's University" in order to regulate for the time being the matters in relation to-

- 1. Faculties of the University
- 2. Faculty-wise breakup of the subjects,
- 3. Board of Studies for every subject or group of subjects,
- Departments in the University and Colleges with the subjects and their corresponding Board of Studies.

The four Faculties, Boards of Studies thereunder, the Departments in the University and Colleges and the subjects / group of subjects, under the Boards of Studies as regulated by the Vice-Chancellor, vide the direction dated 19.07.2017, are as attached with this notification.

All the concerned teachers are hereby requested to fill up the prescribed proforma with attestation by the Principal of the concerned College / Head of the concerned University Department / University Institution / Recognised Institution.
