## **Notice of Election**

Elections of two Representatives of Management by the Senate to the Management Council from amongst Representatives of Management who are the Members of the Senate, as required u/s 30(4)(h) of the Maharashtra Public Universities Act, 2016.

All the Representatives of Management, who are Members of the Senate who are elected u/s 28 (2) of the Maharashtra Public Universities Act, 2016, are hereby notified that the Elections of two Representatives of Management by the Senate to the Management Council as required u/s 30 (4) (h) of the said Act will be held at the meeting of the Senate on  $27^{th}$  February 2018.

Wherein, Section 30 (4) (h) of the Maharashtra Public Universities Act, 2016 states that, two representatives of managements to be elected by Senate from amongst the representatives of management who are members of Senate, and further provided that same management shall not have second consecutive institutional representation. Provided that, out of the two representatives under this clause, one member shall be elected, by rotation, from amongst the Scheduled Castes or Scheduled Tribes, or Denotified Tribes (Vimukata Jatis) or Other Backward Class.

Wherein, the qualifications required for the member thus to be elected under 30 (4) (h) are given in the Notification of the Higher and Technical Education, Notice No. MNS-2016/(347/16)Ue-3 dated  $8^{th}$  April 2017 published in the Gazette of Government of Maharashtra No. Maharashtra Shashan Rajpatra Bhag Char- B, April 29, 2017/ Vaishakh 9, shake 1939 as follows:

(a) Shall possess Bachelors Degree.

(b) Shall be a member of Governing Body/ Management Committee of the

Management for at least two years.

(c) Shall have at least one College or Institution run by such Management having valid Certification of Accreditation by National Assessment and Accreditation Council or National Board of Accreditation, as the case may be and period of validity of such Certificate is unexpired.

(d) Who is not the Representative of such Management which had its Management Representative on the immediately preceding Management

Council of the University.
