**Notice of Election**

**Elections of two teachers who are not principals or directors of recognised institutions by the Senate from amongst the teachers and University teachers who are the Members of the Senate, to the Management Council, as required u/s 30(4)(g) of the Maharashtra Public Universities Act, 2016.**

All the teachers, who are Members of the Senate who are elected u/s 28 (2) of the Maharashtra Public Universities Act, 2016, are hereby notified that the Elections of two teachers who are not principals or directors of recognised institutions by the Senate, from amongst the teachers and University teachers who are the Members of the Senate, to the Management Council as required u/s 30 (4) (g) of the said Act will be held at the meeting of the Senate on 27<sup>th</sup> February 2018.

Wherein, Section 30 (4) (g) of the Maharashtra Public Universities Act, 2016 states that, two teachers who are not principals or directors of recognised institutions to be elected by the Senate from amongst the teachers and university teachers who are the members of the Senate, out of whom one shall be elected from amongst the teachers and university teachers who have been elected from Scheduled Castes or Scheduled Tribes or De-notified Tribes (Vimukta Jatis) or Nomadic Tribes or Other Backward Class categories, by rotation.

Wherein, the qualifications required for the member thus to be elected under 30 (4) (g) are given in the Notification of the Higher and Technical Education, Notice No. MNS-2016/(347/16)Ue-3 dated 8<sup>th</sup> April 2017 published in the Gazette of Government of Maharashtra No. Maharashtra Shashan Rajpatra Bhag Char- B, April 29, 2017/ Vaishakh 9, shake 1939 as follows:

- (a) Shall possess Ph.D. Degree with at least ten years teaching experience in aggregate, Or Shall have at least fifteen years teaching experience in aggregate.
- (b) Shall have undertaken University examination related work for at least five years in aggregate.

It is thus requested that, teachers who are not principals or directors of recognised institutions and who are members of the Senate and who wish to contest the Elections for the membership on the seats of two teachers on the Management Council of the University as required u/s 30(4) (g) of the Maharashtra Public Universities Act, 2016 and fulfil the required qualifications as stated above need to apply to the undersigned in the attached format and send the hard copy as well as soft copy (in Pdf format) on [registrar@sndt.ac.in](mailto:registrar@sndt.ac.in) and cc to [elections2017@sndt.ac.in](mailto:elections2017@sndt.ac.in) on or before 23<sup>rd</sup> February 2018 before 1:00 pm.
