Notification of allocation of reservation on the management council as required u/s 30 (4)(f),(g) and (i) of the Maharashtra public universities act,2016.

The Government of Maharashtra vide letter dated 30.11.2017 had promulgated an ordinance to amend Maharashtra Public Universities Act, 2016 (Maharashtra Ordinance No. XXVIII of 2017), wherein it was expected to ensure that, the persons belonging to all reserved categories get due representation on the Management Council.

The Government of Maharashtra vide letter dated 20.01.2018 has again promulgated an ordinance to amend Maharashtra Public Universities Act, 2016 (Maharashtra Ordinance No. 1 of 2018), wherein it is expected to ensure that, the persons belonging to all reserved categories get due representation on the Management Council.

The Vice-Chancellor has issued the Direction No. 1 of 2018 relating to the reservation by drawing of lots for each reserved category under clauses (f), (g), and (i) of sub section 4 of Section 30 of the Act, for the initial term of Management Council, immediately after the commencement of the Act.

Further the said direction also stated that, Point of rotation for reserved categories under the clauses (f), (g), (h) and (i) of sub section 4 of Section 30 of the "said Act "to be made applicable for the first election after the commencement of Maharashtra Public Universities Act, 2016 shall be decided as under:

- 1. Representative of Management from the reserved category on Management Council under Section 30 (4)(h) shall be from Scheduled Castes.(as the said allocation is carry forwarded from category selected under Section 28 (2)(p) of Maharashtra Universities Act,2016.)
- 2. For the purpose of deciding category of reservation for Principals, Teachers and Registered Graduates as per clauses (f), (g) and (i) of sub section 4 of Section 30, respectively, the committee shall draw lots. Accordingly a Committee for drawing lots was constituted under the chairmanship of Madam Vice-Chancellor for selecting the category for various elections that are to be held at the Senate Meeting on 27th February 2018. The said committee meeting was held on 21st February 2018 and the following is the result of the said draw.

The University thus, hereby declares the allocation of reservation for the Principal, Teacher and Registered Graduate on the Management Council as mentioned below;
