Instructions regarding admission

1. Students seeking admission as well as the Study Centres are informed that admission applications for B.A.-I., B.Com.-I, M.A. I, M.Com. programmes will be accepted between 12th July to 30th July 2022.
2. The Study Center is requested to submit the application form of all the students online at <https://sndtoa.digitaluniversity.ac/> whose admission application you are being accepted in hard copy form through offline mode.
3. Entry level qualification for the B.A. I: The Student must have passed the Higher Secondary Examination (Twelve Exam) (10 + 2) (Arts / Commerce / Science) of the recognized examination Board.
4. Entry Level Qualification for B.Com. I: The Student must have passed the Higher Secondary Examination ((Twelve Exam)) (10 + 2) (Commerce) of the recognized Board of Examination.
5. Entry Level Qualification for M. A. I: The Student must have passed the degree examination of a university recognized by the University Grants Commission.
6. Entry Level Qualification for M.Com. I: The Student must have passed the degree examination of commerce faculty of a university recognized by the University Grants Commission..

For Degree programmes:

1. B. A. / B.Com. First year: Rs.6030 / -
2. B. A. / B.Com. First year (other than Maharashtra State Board): Rs.6330 / -
3. B. A. / B.Com. First year (SC / OBC / VJNT / SBC reserved category students): Rs.1800 / -

For Postgraduate Degree Programmes:

1. M. A. / M.Com. First Year (For SNTD Women's University Graduate Students): Rs.8220 / -
2. M. A. / M.Com. First year (for students other than SNTD Women's University): Rs.8520 / -

Special Note:
