Bachelor of Management Studies (B.M.S.) and Master of Business Administration (M.B.A.) (Distance) Common Entrance Test (CET) 2026 - 2027

Online Applications are invited by the Shreemati Nathibai Damodar Thackersey Women's University, Mumbai from eligible candidates for admission to **UGC-DEB Approved Bachelor of Management Studies (B.M.S.) and Master of Business Administration (M.B.A.)** programme in the Centre for Distance and Online Education (CDOE), SNDT Women's University, Mumbai.

Purpose of Conducting SNDTWU CDOE CET: The SNDT Women's University, Centre for Distance and Online Education (CDOE) shall conduct its own Common Entrance Test (CET) for admission to the BMS and MBA programmes for eligible students who have completed the required qualifying examination but have not appeared for the relevant CET conducted by the Maharashtra State Common Entrance Test Cell/or any such CET. The SNDT CDOE CET will provide an opportunity to such eligible students to seek admission to the BMS and MBA programmes through the **Centre for Distance and Online Education (CDOE)** admission process. **The B.M.S and M.B.A CET is a qualifying test.** MBA (Distance) will only be offered from SNDTWU CDOE headquarter Mumbai only.

The BMS CET will be of 100 marks and MBA CET will be of 200 marks with multiple choice type questions.

Bachelor of Management Studies (B.M.S.) and Master of Business Administration (M.B.A.) will be conducted by online computer-based proctored mode.

There is no negative marking system in the exam.

Questions will be made available in English language only.

Eligibility & Education Qualification for B.M.S. and M.B.A. (Distance) CET:

For Bachelor of Management Studies (B.M.S.)

- The applicant must be a citizen of India.
- 12th/HSC equivalent pass in any stream and those students who have not appeared for the relevant CET conducted by the Maharashtra state common entrance test cell.

For Master of Business Administration (M.B.A.)

- The applicant must be a citizen of India.
- Passed minimum Three-year Duration Bachelor's Degree awarded by any recognized of the University.

Syllabus and Marking Scheme for SNDT-CDOE B.M.S. (Distance) CET - 2026 - 2027

The On Line test will have 100 Questions based on Reasoning (Verbal as well as Arithmetic), English Language & General Awareness including questions on culture, current national, international affairs, trade & commerce, sports, scientific inventions and discoveries, Computer Basics etc.

Syllabus and Marking Scheme for SNDT- CDOE M.B.A (Distance) CET – 2026 - 2027

Syllabus Contents: -

A) Logical/ Abstract Reasoning:

This shall include the questions to measure how quickly and accurately you can think. This test may have questions based on figures and diagrams and also question on verbal reasoning.

B) Quantitative Aptitude:

This shall include the questions to know how fast and accurate you can work with numbers, do numerical calculations, understand various arithmetic problems involving ratio and proportion, percentage, etc. This test also helps to measure your power of quantitative reasoning, interpretation of tables, common graphs and charts.

C) Verbal Ability and Reading Comprehension:

This shall include passages with questions based on their contents to test your comprehension. Your English Language ability would be tested through questions on grammar, vocabulary, sentence completion, synonyms, antonyms, comprehension of passages etc. Your English language ability would be tested through questions on (1) understanding of the contents of the passage and (2) choice of appropriate words, phrases, expressions and similar language skills.

Intake Capacity and Merit

B.M.S:- There is no limit on the intake capacity for the B.M.S. programme admissions to this programmes are allowed various study centres of CDOE across Maharashtra (Study centre list is uploaded on website <https://sndt.ac.in/index.php/cde>).

M.B.A: The intake capacity for the MBA programme is limited to **120 seats**. If the number of eligible applicants exceeds the prescribed intake capacity of specific category, the admissions will be granted on the basis of merit in the SNDT WU, CDOE CET.

In case two or more candidates secure equal marks in the SNDTWU CDOE CET and the number of candidates exceeds the available seats, the merit shall be determined on the basis of the marks obtained in the qualifying examination.

Decision of SNDT-CDOE CET Cell in all matters relating to conduction of CET will be final and binding on the candidate. No correspondence or personal enquiries shall be entertained by the SNDT-CDOE CET Cell in this behalf.

(The **M.B.A (Distance)** is offered only from the SNDT WU CDOE head quarter at Santa Cruz West Mumbai only, and will not be allowed to take admissions from any study centre of CDOE in Maharashtra)

C. SNDTWU- CDOE B.M.S & M.B.A (Distance) CET 2026 Application Fees Payment

Application form processing fees as stated below is to be paid through online system only by Internet Payment, Credit Card/ Debit Card (RuPay/Visa/MasterCard/Maestro), Internet Banking, IMPS, UPI, Cash Cards/ Mobile Wallets, UPI for which the service charges, as per rules, shall be applicable in addition to the application form processing fees. No other mode of payment shall be permitted. This fee is non-refundable and non-transferable under any circumstances.

- ₹ 500/- For Open Category Candidates from Maharashtra State
- ₹ 350/- For Candidates belonging to Backward Class Categories [SC, ST, VJ/DT- NT(A), NT(B), NT(C), NT(D), OBC, SBC, SEBC, EWS] who are residents of Maharashtra State only.
- For Persons with Disability (PWD) candidates belonging to Maharashtra State only.
- For Orphan Candidates
- For Transgender (Other) Candidates

*(In case of SEBC Candidates reservation policy will be subject to the decision of Hon'ble High Court in related Writ Petitions)

- Candidates will be required to submit the Caste Certificate, Caste Validity Certificate and Non-Creamy Layer Certificate (Valid up to 31/03/2027) if applicable
- Candidates will be required to submit Economically Weaker Section Certificate if applicable.
- Candidates will be required to submit Persons with Disability (PWD) Certificate if applicable.



Procedure for Online Application Form Filling and Registration for SNDT WU CDOE BMS & MBA (Distance) CET 2026 - 2027

Application Form for SNDT-CDOE BMS & MBA CET 2026 will be filled through Online Mode only. Online application form is available on web site www.sndt.ac.in / <https://sndt.digitaluniversity.ac.in>

Candidate is advised to download and read the user manual for filling up the online application form. For submission of online application form the candidates should login at <https://sndtwu.ucanapply.com> website. Detailed procedure for online submission of application form is given in the user manual.

Important Guidelines for Candidates.

• Verification of Information

The SNDT WU CET Cell and CDOE reserves the right to verify the candidate's personal details and photographs at any stage of the registration or admission process.

• Aadhaar Details Update

Candidates must ensure that the details on their Aadhaar Card are accurate and updated. This includes:

- Recent photograph
- Name
- Date of birth
- Gender
- Address

Candidates should follow the official UIDAI guidelines for updating Aadhaar information.

• Accuracy of Information

It is the responsibility of the candidate to provide accurate and verifiable information. Any inconsistency or mismatch in Aadhaar or APAAR details may lead to delays or rejection of the application.

• Document Readiness

Candidates are advised to keep all relevant documents readily available during registration to ensure a smooth verification process. — Photo Specifications As part of

the registration process, the application form has the provision to upload the candidate's photograph to complete the examination registration process.

Test Information & Sample Questions: -

The time for the test is 2 hours and 30 minutes; however, you may have to be at the venue for approximately 3 hours. All tests will be provided in English. You can attempt any question at any point of time within these 150 minutes. All the questions will have multiple choices. Out of the five answers to a question only one will be the correct answer. You have to select the most appropriate answer and 'mouse click' that alternative which you feel is appropriate/correct. The alternative/ option that you have clicked on will be treated as your answer to that question. There will be no penalty for wrong answers marked by you. However, you are advised, not to mark answers by random guessing.

Method for percentile calculation and result processing:

Normalization document regarding percentile calculation and result processing will be published on SNDT-CDOE official website.

D. Instructions for filling online SNDT CDOE BMS and MBA (Distance) CET – 2026 – 2027 Application Form

- Before filling the online application, refer all the instruction.
- **Required documents:** Candidate shall upload following documents along with Online Application:
- Scanned copy of Marks Statements of SSC, HSC (For BMS) and SSC, HSC with Degree Marksheet (For MBA)
- Scanned copy of the Caste Certificate in case of Reserved Category Candidates (if applicable).
- Scanned copy of the Non-Creamy Layer Certificate in case of Reserved Category Candidates (if applicable).
- Scanned copy of the Medical Certificate issued by Civil Surgeon in case of persons with Disabilities (P.H.) candidates (if applicable).

General Instructions:

- **Purpose of Conducting SNDTWU CDOE CET:** The SNDT WU shall conduct its own Common Entrance Test (CET) for admission to the BMS and MBA (Distance) programmes for eligible students who have completed the required qualifying examination but have not appeared for the relevant CET conducted by the Maharashtra State Common Entrance Test Cell.



- Decision of SNDT WU-CDOE CET Cell in all matters relating to conduction of CET will be final and binding on the candidate. No correspondence or personal enquiries shall be entertained by the State CET Cell in this behalf.
- MBA will only be offered from CDOE Headquarter Mumbai.
- BMS and MBA both approved by UGC-DEB
- In case of any grievance or disputes the decision of the University shall be final and binding on all.
- Admission to any program does not guarantee hostel facility or any kind of financial support in any form like Scholarship, fellowship, Earn and Learn etc. The University has independent procedures for offering such benefits.
- It is the responsibility of the applicant to fulfil the eligibility conditions and comply with the admission requirements. If at any stage that a false claim has been made by the candidate or the important material facts have been concealed and / or the candidate is not eligible, her candidature shall be liable for cancellation at any stage.
- Incomplete applications / applications without uploading required documents / applications submitted after the due date will be rejected without assigning any reason and no correspondence will be entertained by the University in this regard.
- No request for the change in any information submitted in the online form will be entertained by the University.
- Once the the online link for submitting SNDT WU CDOE CET applications form is closed No request will be entertained thereafter.
- No personal communication will be sent to candidates.
- Fees once paid for CET will not be refunded in any case.
