## NOTIFICATION

**Sub.: Filling of the casual vacancies that have occurred in the office of members of various Boards of Studies before the expiry of their normal term, under Sections 40(2)(b)(i), (b)(ii), (b)(iii), (d)(i), (d)(iii)(B), (d)(iii)(C), (d)(iii)(D), 63 and 70(1) of the Maharashtra Public Universities Act, 2016.**

It is hereby notified for the information of all the concerned that, as per the provision of Section 40(1) of the Maharashtra Public Universities Act, 2016, there shall be a Board of Studies for every subject or group of subjects prescribed by the statutes. The constitution of the Board of Studies shall be as stated in sub-section (2) of the Section 40 of the Act.

Whereas, the Government of Maharashtra, vide Notification no. MNS-2016/(347/167/Ue-3 dated 8<sup>th</sup> April 2017 in exercise of the powers conferred by Section 27 of the said Act, has specified the eligibility conditions for being elected, nominated or co-opted as member of any authority of the University.

Whereas, as per the provision of Section 62(1) of the Maharashtra Public Universities Act, 2016, the term of every authority constituted under the said Act shall commence on 1<sup>st</sup> September and shall be of five years from the said date and the term of the members of every authority shall expire on the expiry of the said period of five years irrespective of the date on which a member has entered upon his office.

Accordingly, as per the afore-mentioned provisions of Section 40(2) and in accordance with the eligibility conditions as specified in Government of Maharashtra Notification dated 8<sup>th</sup> April, 2017, the Boards of Studies in various subjects or groups of subjects have been constituted for a term of five years commencing from 1<sup>st</sup> September 2017, as stipulated under Section 62(1) of the said Act.

However, the casual vacancies in the office of members have occurred on the following Boards of Studies, before the expiry of their normal term of five years as detailed below.

Whereas, as per Section 70(1) & (2) of the Maharashtra Public Universities Act, 2016, when any vacancy occurs in the office of a member, other than an ex-officio member or, a member nominated by the Chancellor, of any authority or body of the University except Management Council before the expiry of his normal term, the vacancy shall be filled by nomination of a person by the Standing Committee constituted under sub-section (3) of Section 70 of the Act, who is otherwise eligible to be elected on the said authority or body from the same category. The person so nominated shall hold office only so long as the member whose place he has been nominated shall have held it, if the vacancy had not occurred.

In view of the afore-stated casual vacancies that have occurred in the office of members on various Boards of Studies as mentioned at paragraph 4 above, before the expiry of their normal term will be filled by the Standing Committee constituted under Section 70 (3) of
