1.	<b>Mr. Vyas Sushil Deviprasad</b>	Open	Since the nomination papers of Mr. Vyas Sushil Deviprasad for the election in question did not comply with the requirement of Section 10(1) of the Uniform Statute No. 1 as referred hereinabove, his nomination has been declared as invalid and the same has been rejected.	<p><b>Mr. Vyas Sushil Deviprasad appeal 28.09.2017</b></p> <p>This is to inform you that we have submitted the nomination form of our college Management Committee member representative. President-Sushil Deviprasad Vyas, Advocate, for the election of six representative of Management of Affiliated Colleges to senate (u/s 28(2) (p) of M.P.U Act. 2016) on 25.09.2017.</p> <p>On 27.09.2017, The S.N.D.T. Women's University declared the status of valid and invalid nomination list, where in our college Management committee member representative, Sushil Deviprasad Vyas, Advocate is not shown in both the list.</p> <p>To the reply to our letter, vide your letter No. Uni.Sec/Elec. Sen./Mgt.Rep/2017-18/187 dated 27/09/2017, mentioned that the nomination form and copies of document were submitted to university office on 25.09.2017 not by candidate in person but by a person who was not authorized by the candidate in writing'. It is very shocking for us to see the reason for rejection of nomination.</p> <p>We would like to pay your attention that the nomination form and copies of documents were submitted by proper authority letter in writing which has been acknowledge by University Office.</p> <p><b>Mr. Vyas Sushil Deviprasad</b></p>	On perusal of the contentions of the appellant and the Registrars letter dt. 28.09.2017 sent Mr. Vyas Sushil Deviprasad declaring his nominations as INVALID and the documents attached therewith, it is evient that, a letter of authority was issued by Mr. Vyas in the name of Mr. Janardan Kharseller for submission of his nomination. It was brought to the notice by the Registrar that, the nomination of the said candidate was submitted by a person to the Affiliation Section of the University on 25.09.2017. However the identity of that person was not verified as to whether he was the same person who was duly authorised to submit the nomination of the candidate. However, the same needed to be ignored as the nomination in question was raised by the University office within the stipulated time limit. Hence, the scrutiny of the said nomination was ordered immediately before me. Accordingly, the Registrar

					<p>scrutinized the nomination papers in the right of eligibility conditions for being elected as a member of the Senate under Section 28(2)(p) of the Maharashtra Public Universities Act, 2016 and the Uniform Statute No. 1 of 2017. However, it was found that, the certificate of Accreditation dt. January 08, 2011 for the B.M. Ruia Girls'College, Mumbai as issued by the N.A.A.C. was valid upto January 07, 2016 only. The eligibility condition of at least one college or institution run by the Management naming Valid Certification of Accreditation by the NAAC or NBA and the period of such certificate be unexpired, as specified by Government of Maharashtra in its notification no. NS-2016/(347/16)/Ue-3 dated 8<sup>th</sup> April, 2017 has not been fulfilled. Meena Khetani Aurhorize Mr. Sandeep Ghodgerao to submit my nomination form for Election of Representatives of Managements of Affiliated Colleges or Institutions to the Sena+ te.</p> <p>I am sorry to state that due to oversight I did not submit the authorization letter to the University Secretariat while submitting my nomination form for Election of Representative of Management of Affiliated Colleges or Institutions to the Senate."</p> <p><b>Ms. Khetani Meena Abay Joint Managing Trustee, SPRJ Kanyashala Trust, Ghatkopar, Mumbai</b></p>	<p>On perusal of the appeal submitted by the appellant namely, Ms. Khetani meena Abhay, it is evident that, she has admitted that, she did not submit her nomination in person nor did she authorise in writing to the person who delivered her nomination to the University office on 26.09.2017. The candidate had therefore not complient complied with the requirement of Section 10(1) of the Uniform Statute No. 1 of 2017. The decision of the Scrutiny Committee to declare the nomination of Ms. Khetani Meena Abhay for the election in question as INVALID is upheld.
