#### NOTICE OF ELECTIONS

# AND RECOGNISED INSTITUTIONS TO THE BOARDS OF STUDIES IN THE CONCERNED SUBJECTS OR GROUP OF SUBJECTS (u/s 40(2)(c) OF THE M.P.U.ACT, 2016)

It is hereby notified for the information of all the concerned that, the Maharashtra Public Universities Act, 2016 (hereinafter referred to as 'Act') under Section 40(2)(c) provides for election of three Heads of Departments from affiliated colleges and recognised institutions to the Boards of studies in the concerned subjects or groups of subjects from amongst the Collegiums of Heads of Departments in the respective subjects from affiliated colleges and recognised institutions for a term of five years.

Accordingly, it is proposed to hold the elections of three Heads of Departments in the following subjects from affiliated colleges and recognised intuitions to the Boards of Studies in the concerned subjects or group of subjects, as per the provision of Section 40(2)(c) of the Act, for a term of five years from September 01, 2017 to August 31, 2017.

- 1. Boards of Studies in Food Science and Nutrition,
- 2. Boards of Studies in Human Development,
- 3. Boards of Studies in Resource Management,
- 4. Boards of Studies in Textiles Science and Apparel Design,
- 5. Boards of Studies in Commerce,
- 6. Boards of Studies in Accountancy,
- 7. Boards of Studies in Business Economics and Statistics,
- 8. Boards of Studies in English,
- 9. Boards of Studies in Gujarati,
- 10. Boards of Studies in Hindi,
- 11. Boards of Studies in Marathi,
- 12. Boards of Studies in Sanskrit,
- 13. Boards of Studies in Sociology,
- 14. Boards of Studies in Psychology,
- 15. Boards of Studies in Economics,
- 16. Boards of Studies in Geography,
- 17. Boards of Studies in History,
- 18. Boards of Studies in Political Science,
- 19. Boards of Studies in Music.

Whereas, as per Section 2(14) of the Act the "Collegium of Heads of Department of affiliated colleges and recognised institutions" means an electoral college consisting of heads of departments from affiliated colleges and recognised institutions who shall elect from amongst themselves as members to the concerned authorities.

Whereas, the Government of Maharashtra, vide its notification dt.28.04.2017 has specified the following eligibility conditions for being elected as a member of the Board of Studies, under aforestated Section 40(2)(c) of the Act, by the Collegium of Heads of Departments from amongst themselves-

- a. Shall possess Ph.D. Degree, unless he is a Principal appointed as a Principal before 13<sup>th</sup> October 2000,
- Shall have at least ten years teaching experience at undergraduate level in aggregate,
- c. Shall have undertaken university examination related work for at least five years in aggregate.

Whereas, as per Section 67(1) of the Act, the elections of three Heads of Departments to the Boards of Studies under Section 40(2)(c) of the said Act shall be held by ballot in accordance with the system of proportionate representation by means of the single transferable vote and as prescribed by the Statutes.

The above elections shall be held at four Polling Centres as listed in the Programme of Elections. The following detailed programme of elections is published on the Election Portal by the University on its official website <a href="www.sndt.ac.in">www.sndt.ac.in</a> and also displayed on the designated notice board.

#### **Nominations**

- 1. As, per the provision of Section 19(1) of the Maharashtra Public Universities (Procedure for conduct of Election to various Authorities and Bodies of the University) Uniform Statute, 2017 (Uniform Statute No.1 of 2017), the Heads of Departments whose names have been included in the Final Electoral Roll for the Collegiums of Heads of Departments as prepared by the University, under Section 8(5) of the said Uniform Statute and who desire to contest the election shall be required to submit their nominations for the election in the prescribed Nomination Form along with the copies of the following documents in person or through a person authorised by him / her in writing, at the office of the Registrar before 5.00 p.m. on the last date fixed for receiving nominations i.e. October 06, 2017.
  - i. Copy / copies of the letter (s) of appointment as teacher
  - ii. Copy of the Ph.D. Degree Certificate.
  - iii. Copies of teaching experience certificate(s) issued by the competent authority.
  - iv. Copies of experience certificate(s) of having undertaken University Examinations related work.
  - v. Copies of letter (s) of approval of the University as full time teacher.
- 2. The nominations received by post or through courier or by email shall not be considered.
- 3. The nomination papers must be dated and signed by two electors entitled to vote and should contain dates, names in full, addresses and designation if any and voter number (as mentioned in the Final Electoral Roll) of signatories and of the candidate nominated.
- 4. No person shall be nominated as a candidate for election unless he / she signifies his / her consent under his / her signature and date on the nomination paper. No person shall either propose or second his / her own nominations:

Provided that, in case there are less than three voters, the candidate himself may propose and second his own nomination.

5. A nomination paper which does not comply with all the requirements herein mentioned shall be invalid and it shall be rejected.

#### **Scrutiny of Nomination Forms**

The scrutiny of nomination papers shall be carried out on October 07, 2017 at 11.00 a.m. onwards at the Premlila Thackersey Hall, S.N.D.T. Women's University, Churchgate Campus, Mumbai – 400 020. The candidate or his / her agent whose name has been included in the Final Electoral Roll duly authorized by the candidate in writing in that behalf shall be entitled to be present at the scrutiny.

#### Notifying the names of valid and invalid nominations

After the scrutiny of nomination papers, the list of valid and invalid nominations shall be notified the same day.

#### Dispute about validity of nomination

In the case of dispute or doubt regarding the validity of a nomination paper, an appeal may be made to the Vice-Chancellor within the stipulated time limit and the decision of the Vice-Chancellor shall be final.

#### Withdrawal of nomination

It shall be open to a candidate to withdraw from an election, provided he/she submits an application for withdrawal signed by the candidate, in person or through a person authorized by him / her, in writing, at the Office of the Registrar, Churchgate Campus, Mumbai – 20 on or before October 11, 2017 upto 4.30 p.m.

#### Notifying the names of contesting candidates

The names of the contesting candidates shall be published on a date as specified in the Programme of Election.

#### **Uncontested Election**

If the number of valid nomination does not exceed the number of vacancies to be filled, the candidates nominated shall be declared to have been elected on the date of declaration of result of Election.

#### Procedure for Election at Polling Centre

The procedure for the recording of votes by ballot shall be as prescribed by the Uniform Statute No.1 of 2017, under Section 12.(Copy is available on "Election Portal").

#### Scrutiny of Voting Papers and counting of Voting Papers

The scrutiny of voting papers and counting of voting papers shall be carried out on the date and time as stated in the Programme of Election, as per the procedure prescribed under Section 13, 14 & 15 of the Uniform Statute No.1 of 2017.

#### Result of Scrutiny and counting of Voting Papers

After the scrutiny and counting of voting papers, the result thereof shall be reported to the Vice-Chancellor by the Registrar.

On the result of the election being reported to the Vice-Chancellor, the result of counting showing for each candidate, the number of first votes obtained and the successive additions or subtractions from the number till the candidate was excluded or elected, shall be declared by the Registrar.

#### **Appeal**

No demand of recounting shall be entertained after the final rounds are over. The candidate or the representative may raise objection at the end of particular count, if he/she desires. He / She can not raise any objection if the process of counting is entered into the next rounds.

An appeal against the result of election shall be preferred to the Vice-Chancellor within thirty days from the date of declaration of the result.

#### Counting of University Examination related work in aggregate years

The University Examination related work in aggregate years shall be counted as per the directions of the Vice-Chancellor, issued vide order no.SNDT /VC-Dir/ U.E.W.Counting /2017-18/ dated September 06, 2017.

#### **Collegium of Heads of Departments**

The "Collegium of Heads of Department of affiliated colleges and recognised institutions" means an Electoral College consisting of heads of departments from affiliated colleges and recognised institutions who shall elect from amongst themselves as members to the concerned authorities as published vide notification no. Univ.Sec. /Elec.BOS /HOD/ F.E.R./2017-18/163 dated September 15, 2017 is available on the Election Portal of the University on its Website <a href="https://www.sndt.ac.in">www.sndt.ac.in</a>
