As per the *section 11 of Uniform statues no. 1 of 2017* the above election shall be held by ballot in the first meeting of senate scheduled on **08.02.2023** at SNDT Women's University, Ground Floor Churchage Campus, Mumbai – 400 020.

It may be noted that, as per the provision of *Section 10(8) of the Uniform Statute No.1 of 2017*, if the number of valid nominations does not exceed the number of vacancies to be filled, the candidates nominated shall be declared to have been elected on the date of declaration of result of election.

As per the Section 18(1) of the Uniform Statute No.1 of 2017, if any candidate is elected, nominated or co-opted to any authority or body in more than one capacity, he shall by notice in writing signed by him and delivered to the Registrar of the University within seven days of the declaration of the result of the last date of such election, nomination or co-option, as the case may, choose which of the capacities he shall hold, and such choice shall be conclusive.

The membership of any authority of the University is subject to the *section 64* related to the disqualification of the membership from authority as per the *Maharashtra Public University act 2016.*
