All the concerned are hereby informed that, as per Section 30(4)(f) of the Maharashtra Public Universities Act, 2016, the Schedule of Election approved by the Vice-Chancellor, the election of Two principals to be elected by the Senate from amongst the principals who are the members of the Senate, out of whom one shall be elected from amongst the principals who have been elected from Scheduled Castes or Scheduled Tribes or Denotified Tribes (Vimukta Jatis) or Nomadic Tribes or Other Backward Class categories, by rotation.

Whereas, the scrutiny and counting of voting papers of the said election was carried out by a committee as authorised by the Registrar on **February 08, 2023** onwards at the Churchgate Campus of the University, Mumbai – 400 020, in the presence of candidates and/or their authorised agents.
