## DECLARATION OF RESULT ELECTION OF TWO REGISTERED GRADUATES TO BE ELECTED BY THE SENATE TO THE MANAGEMENT COUNCIL (U/S 30(4)(i) OF M.P.U. Act, 2016)

All the concerned are hereby informed that, as per Section 30(4)(i) of the Maharashtra Public Universities Act, 2016, the Schedule of Election approved by the Vice-Chancellor, the election of Two registered graduates elected by Senate from amongst elected registered graduate members of Senate, out of whom one shall be elected from amongst the registered graduates who have been elected from Scheduled Castes or Scheduled Tribes or De-notified Tribes (Vimukta Jatis) or Nomadic Tribes or Other Backward Class categories, by rotation.
