**DECLARATION OF NAMES OF CANDIDATES
CONTESTING THE ENSUING ELECTION OF TWO REGISTERED GRADUATES
TO BE ELECTED BY THE SENATE TO THE MANAGEMENT COUNCIL
(U/S 30(4)(i) OF M.P.U. Act, 2016)**

It is hereby notified for the information of the concerned that, as per the circular no. Univ. Sec./Principals-Sen. to M.C./Scrutiny/2022-23/499 dt. January 25, 2023, the list of valid and invalid nominations was declared by the University for *the election of Two registered graduates elected by Senate from amongst elected registered graduate members of Senate, out of whom one shall be elected from amongst the registered graduates who have been elected from Scheduled Castes or Scheduled Tribes or De-notified Tribes (Vimukta Jatis) or Nomadic Tribes or Other Backward Class categories, by rotation; under Section 30(4)(i) of the Maharashtra Public Universities Act, 2016.*

The notice of valid and invalid nominations was communicated to all the concerned through e-mail and uploaded on the Election Portal of University's official website. The last date for withdrawal of nominations was January 30, 2023.

Whereas, as per the provision of *Section 12(4) of the Uniform Statute No.1 of 2017*, the names of contesting candidates for the aforesaid election of Two Registered Graduates to be elected by the Senate to the Management Council *under Section 30(4)(i) of the Maharashtra Public Universities Act, 2016*, is hereby notified for the members of Senate.

As per the *section 11 of Uniform statutes no. 1 of 2017* the above election shall be held by ballot in the first meeting of senate scheduled on **08.02.2023** at SNTD Women's University, Ground Floor Churchage Campus, Mumbai - 400 020.

It may be noted that, as per the provision of *Section 10(8) of the Uniform Statute No.1 of 2017*, if the number of valid nominations does not exceed the number of vacancies to be filled, the candidates nominated shall be declared to have been elected on the date of declaration of result of election.

As per the Section 18(1) of the Uniform Statute No.1 of 2017, if any candidate is elected, nominated or co-opted to any authority or body in more than one capacity, he shall by notice in writing signed by him and delivered to the Registrar of the University within seven days of the declaration of the result of the last date of such election, nomination or co-option, as the case may, choose which of the capacities he shall hold, and such choice shall be conclusive.

The membership of any authority of the University is subject to the *section 64* related to the disqualification of the membership from authority as per the *Maharashtra Public University act 2016*.
