DECLARATION OF RESULT

**ELECTION OF TWO REPRESENTATIVES OF MANAGEMENT TO BE ELECTED BY THE
SENATE TO THE MANAGEMENT COUNCIL
(U/S 30(4)(h) OF M.P.U. Act, 2016)**

All the concerned are hereby informed that, as per *Section 30(4)(h) of the Maharashtra Public Universities Act, 2016*, the Schedule of Election approved by the Vice-Chancellor, the election of *Two representatives of managements to be elected by Senate from amongst the representatives of management who are members of Senate, and further provided that same managements shall not have second consecutive institutional representation: Provided that, out of the two representatives under this clause, one member shall be elected, by rotation, from amongst the Scheduled Castes or Scheduled Tribes, or De-notified Tribes (Vimukata Jatis) or Other Backward Class.*

The elections were scheduled in the First meeting of Senate i.e. on **February 08, 2023** in accordance with the eligibility conditions for being elected as a member of the Management Council as specified by the Government of Maharashtra, in its Notification No. MNS-2016/(347/(16)/e-3 dt. 28th April, 2017 in Sr.No.1(iii) of Schedule I and as per the procedure as prescribed by the Maharashtra Public Universities (Procedure for Conduct of Elections to various Authorities and Bodies of the University) Uniform Statute 2017 (Uniform Statute No.1 of 2017).

Whereas, the scrutiny and counting of voting papers of the said election was carried out by a committee as authorised by the Registrar on **February 08, 2023** onwards at the Churchgate Campus of the University, Mumbai - 400 020, in the presence of candidates and/or their authorised agents.

The result of the said election, after completion of scrutiny and counting on being reported forthwith to the Vice-Chancellor is hereby declared for the information of all the concerned, as per the provision of *Section 16(1) & (2) of the Uniform Statute No.1 of 2017*, as under:

Term of office of members of the Management Council

As per the provision of *Section 62 of the Maharashtra Public Universities Act, 2016*, the term of the members who have been declared elected to the Management Council shall be five years commencing from September 01, 2022 and expire on August 31, 2027, irrespective of the date on which the aforesaid members have entered upon his /her office, subject to the provision of *Section 63* of the Act.

The membership of any authority of the University is subject to the *section 64* related to the disqualification of the membership from authority as per the *Maharashtra Public University act 2016*.
