

Accordingly, the corrections as reported by the concerned Principals/Directors have been duly carried out after verification, as per the provision of Section 8(4) of the aforesated Uniform Statute No.1 of 2017.

The Corrected Electoral Roll of the Principals has now been accordingly prepared and published herewith by the University on the "Election Portal" on its website www.sndt.ac.in. In case of any dispute, an appeal against the said Corrected Electoral Roll shall be made to the Hon'ble Vice-Chancellor's Office on or before **1st September 2022 upto 5:00 pm**. The Hon'ble Vice-Chancellor's decision shall be final on the same.
