**PREPARATION OF ELECTORAL ROLL FOR ELECTION OF TEN PRINCIPALS TO THE
SENATE, UNDER SECTION 28(2)(o) OF THE MAHARASHTRA PUBLIC
UNIVERSITIES ACT, 2016.**

It is hereby notified for the information of the Principals that, as per the provisions of Section 28(2)(o) of the Maharashtra Public Universities Act, 2016, ten Principals of affiliated, conducted, autonomous college which are accredited by National Assessment and Accreditation Council (NAAC) or National Board of Accreditation (NBA), as the case may be, to be elected to the Senate by the collegiums of Principals from amongst themselves, of whom one each shall be a person belonging to Scheduled Castes, Scheduled Tribes, De-notified Tribes (Vimukta Jatis) or Nomadic Tribes, Other Backward Classes, and one shall be a woman, for a term of five year from September 01, 2022 to August 31, 2027.

Whereas, as per Section 2(44) of the Maharashtra Public Universities Act, 2016, "Principal" means a teacher who is duly approved as a Principal by the University.

In view of the aforesaid provision of Section 28(2)(o) of the Maharashtra Public Universities Act, 2016, it is proposed to prepare Electoral Roll of Principals as defined under Section 2(44) of the said Act, for the purpose of election of ten Principals to the Senate.

All the Principals are requested to fill up the prescribed proforma (Annexure-A) with attestation by the President / Secretary of the Management of the concerned college, the duly filled in proforma alongwith the copies of required documents should reach the office of the undersigned (only in hard copy) on or before June 30, 2022 upto 5.00 p.m.. The other details of the election in question will be displayed on the University Website - www.sndt.ac.in ("Election Portal" be seen).
