**DECLARATION OF RESULT OF ELECTION OF TEN PRINCIPALS OF  
AFFILIATED, CONDUCTED, AUTONOMOUS COLLEGES TO THE SENATE BY  
THE COLLEGIUM OF PRINCIPALS FROM AMONGST THEMSELVES, UNDER  
SECTION 28(2)(o) OF THE M.P.U ACT, 2016**

All the concerned are hereby informed that, as per the Schedule of Election approved by the Vice-Chancellor, the election of ten Principals of affiliated, conducted, autonomous colleges which are accredited by National Assessment and Accreditation Council (NAAC) or National Board of Accreditation (NBA), as the case may be, to the Senate by the Collegium of Principals from amongst themselves, of whom one shall be a person belonging to Scheduled Castes, Scheduled Tribes, De-notified Tribes (Vimukta Jatis) or Nomadic Tribes, Other Backward Classes and one shall be a woman, the elections were scheduled on , **November 28, 2022**, under Section 28(2)(o) of the Maharashtra Public Universities Act, 2016 and in accordance with the eligibility conditions for being elected as a member of the Senate as specified by the Government of Maharashtra, in its Notification No. MNS-2016/(347/(16)/e-3 dt. 28<sup>th</sup> April, 2017 in Sr.No.1(iii) of Schedule I and as per the procedure as prescribed by the Maharashtra Public Universities (Procedure for Conduct of Elections to various Authorities and Bodies of the University) Uniform Statute 2017 (Uniform Statute No.1 of 2017).

Whereas, the scrutiny and counting of voting papers of the said election was carried out by a committee as authorised by the Registrar on November 29, 2022 at 11.00 a.m. onwards at the Churchgate Campus of the University, Mumbai – 400 020, in the presence of candidates and /or their authorised agents.


