CORRIGENDUM

NOTIFICATION

In supersession to the University Notice reference no. Univ. Sec./Reg.Grad(Senate) Notice/2022-23/82 dated 14.06.2022 and circular Ref. No.Univ.Sec/Election 2022/2022-23/115 Dated July 11, 2022 pertaining to Notice for Registration of Graduates/ Revision of details of Registered Graduates and Enrolment in Electoral Roll of Registered Graduates for Election 2022, be read as under:

In the connection, Section 131 (1) of the Maharashtra Universities Act, 2016 and subject to Provisions of sub Section (2) the following persons shall be entitled to have their names enclosed :

(1) Subject to the provisions of sub-section (2), the following shall be entitled to have their names entered in the register or registered graduates or deemed to be registered graduates of the university;

- (a) Who are graduates of the university.
- (b) Who are graduates of the parent university from which corresponding new university is established:

Provided that, the graduates registered in the parent university as registered graduates but residing in the jurisdiction of the new university will have to apply for registration, as registered graduates with the new university, they will automatically cease to be the registered graduates of the parent university.

The procedure for Graduates, who intends to enrol their names as Registered Graduates on the Electoral Roll of the University may enter their names as follows:

1. The prescribed application for registration graduates/ revision is available on the University website [www.sndt.ac.in](http://www.sndt.ac.in) (see "Election portal").
2. The application can be submitted through hard copy or by email.
3. Duly filled application form with requisite documents and prescribed fee be submitted to the Registered, SNDT Women's University, Churchgate Campus, Mumbai - 400 020.
4. The attested copies of the following documents must be attached with the application for registration (Form A) / revision (Form B)
  - i. Degree Certificate
  - ii. Proof of residence (Any of the following - Aadhar Card, Pan Card, Election Card, Passport, Bill of Electricity consumption or Driving License)
5. If there is any change in name, a copy of the Government Gazette or Aadhar Card with new name is attached.
6. In case of submission of application form in hard copy the registration fee Rs. 20 to be paid by DD or by I.O.P. drawn in favour of "The Registrar, SNDT Women's University, "payable at Mumbai" or by cash deposit in person at the University Accounts Section, Churchgate Campus, Mumbai - 400 020.
7. The Graduates can also submit the scanned copy of application through email along with the documents mentioned above through their personal email ID to [elections2022@sndt.ac.in](mailto:elections2022@sndt.ac.in)
8. In case of application received through email, the online payment link for payment of Rs. 20 will be made available to concerned graduate on their email id or phone no. the graduates' are require to pay through the link and forward the receipt to [elections2022@sndt.ac.in](mailto:elections2022@sndt.ac.in). The online payment must be made till 22<sup>nd</sup> October 2022 till 11.55 pm midnight as per IST.
9. Last date to submit applications in hard copy or through email is 22<sup>nd</sup> October, 2022 upto 5.00 pm.
10. Graduates who had applied earlier need not apply again.
