It is hereby notified for the information of the concerned voters that, as per the circular no. Uni.Sec./Elec.Sen./Uni. Teachers/Scrutiny/2022-23/334 dt. November 09, 2022, the list of valid and invalid nominations for the election of three University Teachers, to the Senate, under Section 28(2)(s) of the Maharashtra Public Universities Act, 2016 was published by the University on the Election Portal on its official website. The last date for withdrawal of valid nominations as stated in the Schedule of the aforesaid Election was November 17, 2022.

It may be noted that, as per the provision of Section 10(8) of the Uniform Statute No.1 of 2017, if the number of valid nominations does not exceed the number of vacancies to be filled, the candidates nominated shall be declared to have been elected on the date of declaration of result of election i.e. November 29, 2022 at 4.30 p.m.

As per the provision of Section 18(1) of the Uniform Statute No.1 of 2017, if any candidate is elected, nominated or co-opted to any authority or body in more than one capacity, he shall by notice in writing signed by him and delivered to the Registrar of the University within seven days of the declaration of the result of the last date of such election, nomination or co-option, as the case may, choose which of the capacities he shall hold, and such choice shall be conclusive.
