B.Ed./M.Ed. Common Entrance Test (CET) - 2024

Online Applications are invited by the Shreemati Nathibai Damodar Thackersey Women's University, Mumbai from eligible candidates for admission to B.Ed. / M.Ed. programme in the affiliated colleges situated in the states other than Maharashtra.

Candidate shall be admitted to B.Ed. /M.Ed. programme by a one stage process through: -

B.Ed. / M.Ed. CET is a qualifying test. The CET will be of 100 marks with multiple choice type questions.

➤ **Schedule of B.Ed./M.Ed. CET Exam:**

1. Date of online Examination	: 29.09.2024
2. Commencement of filling online applications	: 12.09.2024
3. Last date of filling online applications	: 23.09.2024
4. Mock Test will be Conducted	: 26.09.2024
5. Result Declaration	: 03.10.2024

- No separate certificate of result will be issued by the University.
- Both B.Ed. / M.Ed. CET will be conducted by online computer-based proctored mode.
- There is no negative marking system in the exam.
- Questions will be made available in both Hindi and English languages.

A. Eligibility for admission to B.Ed./M.Ed. programme:

For B.Ed.: -

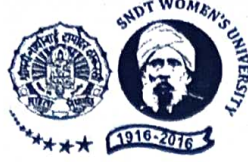
The applicants must go through the MAH B.Ed. CET-2024 eligibility criteria before considering the application for the exam. The detailed eligibility criteria for B.Ed. CET is given below:

Nationality: The applicant must be a citizen of India.

Education Qualification: The applicant must have a Bachelor's degree/master's degree in any of the course like science and mathematics / social sciences / Humanities / Commerce etc.

The candidate should have minimum 50% marks if belonging to General Category and 45% marks if belonging to the reserved category.

OR



The applicant must have a Bachelor's degree/master's degree in subjects like Engineering & Technology, Computer Science/ Law/ Information technology/ Agriculture/ Banking and Insurance/ Medical Sciences/ Fine Art/ Performing Art.

They must have secured a minimum of 55% marks for the General category and 50% marks for the reserved category belonging to the state of Maharashtra.

(Reservation and relaxation for SC/ST/OBC/PWD and other applicable categories shall be as per the rules of the state of Maharashtra whichever is applicable).

For M.Ed.:-

Nationality: The applicant must be a citizen of India.

A. Candidates seeking admission to the M.Ed. programme should have obtained at least 50% marks of an equivalent grade in the following programmes:

- (i) B.Ed.
- (ii) B.A.B.Ed. / B.Sc. B.Ed.
- (iii) B.El.Ed.
- (iv) D.El.Ed. with an Undergraduate degree (with 50% marks in each)

B. Pass in CET of Government of Maharashtra

(Reservation and relaxation for SC/ST/OBC/PWD and other applicable categories shall be as per the rules of the state Govt. whichever is applicable).

- ✓ Scanned copy of the Non-Creamy Layer Certificate in case of Reserved Category Candidates (if applicable).
- ✓ Scanned copy of the Medical Certificate issued by Civil Surgeon in case of persons with Disabilities (P.H.) candidates (if applicable).

❖ **General Instructions:**

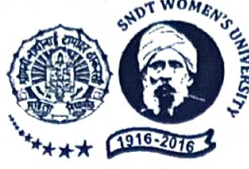
- i. In case of any grievance or disputes the decision of the University shall be final and binding on all.
