1. First Year Under Graduate Degree Courses in the case of Three Years Bachelor Degree Courses -
College level Examinations.
2. First Year Graduate Diploma Courses in the case of Two / Three / Three and Half Years Diploma Courses -
College level Examinations.
3. First and Second Year Under Graduate Degree Courses in case of Four and Five Years Bachelor Degree Courses - (other than the B.Pharm., B.Tech., B.Ed., B.Ed.,(Spl) and B.Sc. Nursing) -
College level Examinations.
4. First and Second Year Under Graduate Diploma Courses in case of Four and Five Years Diploma Courses –
College level Examinations.
5. All B.Pharm., B.Tech., B.Ed., B.Ed. (Spl) and B.Sc. Nursing Under Graduate Degree Courses–
University level Examinations.
6. All Post Graduate Degree and Post Graduate Diploma Courses –
University level Examinations.
