SNDT Women's University has displayed the Citizen's Charter on the website, which can be accessed at https://sndt.ac.in/pdf/citizencharter/sndt-womens-university-citizens-charter.pdf. The university's Citizen's Charter consist of the roles and duties of different administrative departments, including the Examination, Accounts, Affiliation, and Secretariat units. It also provides details such as names, contact information, and responsibilities of personnel within these departments. Additionally, it stipulates timeframes within which specific services should be provided after receiving requests, and officers are expected to adhere to these deadlines as outlined in the charter. The conduct of administrators and staff members is governed by the provisions of the Citizen's Charter. Likewise, the colleges and departments within the university have published their respective Citizen's Charters on their websites. These charters outline the organizational hierarchy, as well as the duties of teaching and non-teaching staff members.

In addition to the Citizen's Charter, which sets standards for conduct, the university and colleges have established various committees, such as the Anti-Ragging Committee and Internal Complaints Committee. The Anti-Ragging Committee is tasked with preventing and addressing incidents of ragging on campus, while the Internal Complaints Committee is responsible for preventing, prohibiting, and addressing cases of sexual harassment involving women employees and students. These committees are constituted in accordance with guidelines set forth by the UGC.
